A RESOLUTION AUTHORIZING DOUGLAS E. CADE, HANCOCK COUNTY ENGINEER, TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION (OPWC) STATE CAPITAL IMPROVEMENT AND/OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S) AND TO EXECUTE CONTRACTS AS REQUIRED.

WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure, and

WHEREAS, the Council of the Village of Vanlue are planning to make capital improvements to Crawford Street - John Street to end of Park Drive, Railroad Lane - North Side of 300 Block East Main Street, Crawford to East Street, Magnolia Lane - 301 Block East North to East Main Street, Railroad Lane - North Side of 200 Block East Main St - Crawford Street to Buffalo Street, Fir Lane - 200 Block East North to East Main Street, East North Street - East Street to East Corp Limit, Wildcat Lane - 419 East North to rear of School, Willow Lane- 209 East Street to Wildcat Lane, Railroad Lane - 100 Block of West Main- Main Cross to Maple Street, Buckeye Lane - 113 West North to Main Street, Deer Lane - 117 (East Side) West North to Main Street, Catawba Lane - 117 (West Side) West North to Main Street, Graves Lane - East Street to 305 South High, Oak Lane - 317 South High to Graves Lane, Fir Lane - 205 East Main to North High Street by resurfacing the pavement, and

WHEREAS, the infrastructure improvement herein described above is considered to be a priority need for the community and is a qualified project under the OPWC programs, and

WHEREAS, the <u>Townships of Amanda</u>, <u>Blanchard</u>, <u>Cass</u>, <u>Jackson</u>, <u>Liberty</u>, <u>Orange</u>, <u>and Van Buren</u>, the <u>Villages of McComb and Vanlue</u> and <u>Hancock County</u> and would benefit from having the bid process and contracts for road resurfacing combined among the Townships, the Villages, and the County

NOW THEREFORE, BE IT RESOLVED, by the Council of the Village of Vanlue:

SECTION 1: That Douglas E. Cade, Hancock County Engineer, is hereby authorized to apply to the OPWC for funds as described above, and is further authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.
