

## ORDINANCE 2023-09

AN ORDINANCE PROVIDING FOR THE AMENDMENT OF ORDINANCE NO. 2015-12 ENACTING AN INCOME TAX IN THE VILLAGE OF VANLUE, OHIO IN ACCORDANCE WITH THE PROVISIONS AND LIMITATIONS SPECIFIED IN CHAPTER 718 OF THE OHIO REVISED CODE, AS AMENDED BY HB33, EFFECTIVE JANUARY 1, 2024, AND DECLARING AN EMERGENCY.

The Village Council having been made aware of the signing of HB33 by Governor DeWine and further being informed by the City of Findlay Tax Department of the need to amend the prior ordinance in order to adopt any tax changes necessary to become effective January 1, 2024, and

WHEREAS, it is necessary that the ordinance be amended by January 1, 2024 such that any income or withholding tax is "levied in accordance with the provisions and limitations specified in Chapter 718," and that pursuant to HB33 this Ordinance is found and determined by this Council to enact the amendments required prior to the January 1, 2024 deadline to be in accord with the provisions and limitations specified in Chapter 718 of the Revised Code;

BE IT RESOLVED by the Council of the Village of Vanlue, State of Ohio, Two-Thirds (2/3) of all members elected thereto concurring that:

SECTION 1: That a complete copy of the text of the income tax regulations are attached hereto as "Exhibit A" and made a part hereof as fully and completely as if written herein.

SECTION 2: To such extent as necessary to comply with HB33, Ordinance No. 2015-12 is hereby amended to comply with chapter 718 of the Ohio Revised Code, as amended by HB33.

SECTION 3: That this Ordinance shall take effect and be in force from and after January 1, 2024.

This Ordinance is hereby declared to be an emergency measure for the immediate preservation of the public peace, health, and safety of the inhabitants of the Village of Vanlue, Ohio and for the further reason it is immediately necessary to comply with the mandates of HB33.
