

## ORDINANCE 2024-01

**AN ORDINANCE EMPLOYING JOHN C. FILKINS AS VILLAGE SOLICITOR FOR THE VILLAGE OF VANLUE, OHIO FOR THE YEARS 2024 AND 2025, AND ESTABLISHING A SALARY THEREFORE AND DECLARING AN EMERGENCY.**

BE IT ORDAINED by the Village of Vanlue, Ohio, two-thirds (2/3) of all members elected theretoconcurring:

SECTION 1: That John C. Filkins be and the same is hereby employed as Village Solicitor for the Village of Vanlue, Ohio, for the years 2024 and 2025.

SECTION 2: That John C. Filkins shall be paid the sum of Four Hundred Dollars (\$400.00) per month for any and all ordinary legal services performed for the Village of Vanlue, Ohio.

SECTION 3: That John C. Filkins shall be compensated in the amount of Seventy Dollars (\$70.00) per hour for any and all extraordinary legal services performed for or on behalf of the Village of Vanlue, Ohio. It is understood that said services, if any, shall be discussed with Council and authorized by Council by a majority vote prior to commencement of any such legal services.

SECTION 4: That John C. Filkins shall be compensated in the amount of One Hundred Dollars (\$100.00) per hour for any and all extraordinary legal services relating to any grant funded projects performed for or on behalf of the Village of Vanlue, Ohio.

SECTION 5: That said compensation shall be authorized and paid at the first regularly scheduled meeting of the Village Council during each month.

SECTION 6: That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the inhabitants of the Village of Vanlue and for the further reason it is immediately necessary to employ a village solicitor for the year 2024 and establish a salary for said services.

BE IT THEREFORE RESOLVED, that it is found and determined that all deliberations and actions of Council concerning and related to the passage of this Ordinance were held in meeting open to the public in compliance with all legal requirements including section 121.22 of the Ohio Revised Code.
